

LIMITED WARRANTY

PLECTRON CORPORATION warrants to the original purchaser, each new electronic product manufactured by them to be free from defective material and workmanship and agrees to remedy any such defect or to furnish a new part in exchange for any part of any unit of its manufacture which, under normal installation, use, and service, discloses such defect, provided the unit is delivered by the original buyer to the factory, intact, for examination, within one (1) year (except batteries) from the date the equipment was shipped to original purchaser; and provided such equipment discloses, in our judgment, that it is thus defective.

BATTERY WARRANTY (Rechargeable Batteries Only) is as follows:

1. First six (6) months, no charge.
2. From six (6) through nine (9) months, list price less 75%.
3. From nine (9) through twelve (12) months, list price less 50%.
4. Over twelve (12) months, no warranty.

All parts returned under the terms of this warranty will be replaced without charge to the owner if examination discloses parts to be defective.

All units returned to the factory within one (1) year from the date stamped on the nameplate or date received and accepted for service under the terms of this warranty, will be repaired without charge to the owner and, in addition, for the first 90 days, all shipping charges will be paid, (or refunded if prepaid) provided the equipment is returned by the carriers designated below. After the first 90 days and for the remainder of the one (1) year warranty period, **ALL TRANSISTOR EQUIPMENT** returned to the factory **PREPAID** under the terms of this warranty, will be repaired and **RETURNED PREPAID**.
