

## **REVCON 250 WARRANTY**

This warranty is expressly in lieu of all other warranties, express or implied, including any implied warranty of merchantability or of fitness. There are no warranties which extend beyond the description on the face hereof.

Revcon Incorporated does hereby warrant its Motor Home when purchased new as follows, subject to the following terms and conditions:

The entire coach body is warranted against defects in material and workmanship for the lifetime of the Motor Home, so long as it is owned by the original purchaser.

The rear running gear, (springs, axle, bearings, and component parts, but excluding brake lining) are warranted against malfunctions resulting from defects in material and workmanship for a period of twelve (12) months, or twelve thousand (12,000) miles, whichever first occurs; provided, however, that if the odometer mileage has been altered and the actual mileage cannot be readily determined, then this provision shall be void.

The chassis components constituting the Oldsmobile end product, (engine, transmission and differential) are warranted by Revcon Incorporated against malfunctions resulting from defects in material and workmanship for a period of twelve (12) months or twelve thousand (12,000) miles, whichever first occurs; provided, however, that if the odometer mileage has been altered and the actual mileage cannot be readily determined, then this provision shall be void.

Revcon Incorporated does not extend its Warranty, express or implied, to the appliances, equipment and accessories, all of which are furnished by other manufacturers. The warranties available on these products are provided by the individual manufacturers and are delivered with each new vehicle. To facilitate warranty work on such appliances, equipment and accessories, requests for repairs and adjustments should be made to the authorized warranty stations designated by such manufacturers.

This Warranty shall not apply to any damage arising from accident, neglect, misuse or latent defects not apparent upon inspection; and shall not apply to failure resulting from lack of proper maintenance, or from normal wear and tear. This Warranty is applicable only when the Motor Home is driven in a reasonable manner and in conformity with all laws, ordinances and regulations and under normal highway conditions, and only when the Motor Home is used within the United States and Canada.

Revcon Incorporated shall fulfill this Warranty at its plant, or at any service center it designates, and shall repair or replace (at Revcon's option) defective parts, or defects in workmanship, about which the purchaser shall have notified Revcon within thirty (30) days after discovery of such defects. Unauthorized repairs or alterations to any part, or use of part not made or supplied by Revcon Incorporated, shall void this Warranty.

Before any repair or replacement under this warranty is instituted by the owner, said owner shall contact the Revcon service department, who shall then issue a warranty repair order number, which will then be the owner's authorization to proceed with such designated repair and/or replacement. The owner shall make payment for all such authorized warranty work and, upon submission of all invoices for this authorized work together with the repair order number, he will be reimbursed by Revcon Incorporated to the full extent of this warranty.

It shall be Revcon's option to have defective or malfunctioning parts returned to its service center, and any authorization to return such malfunctioning or defective part must be done in writing prior to the return. If Revcon desires the return of any malfunctioning parts, reimbursement under this warranty will be effective only after receipt of the returned parts so required.

Revcon Incorporated does not undertake responsibility to any purchaser for any representation or warranty made by dealers selling its products beyond those herein expressed. Revcon Incorporated reserves the right to make changes in design and improvements upon its products without imposing any obligation upon itself to install these changes and improvements upon its Motor Homes theretofore manufactured. The foregoing shall constitute the sole and exclusive remedies available to the owner of a Revcon Motor Home for breach of warranty, and Revcon Incorporated shall not be liable for special damages resulting from loss of the use of the vehicle, or for any delay in the performance of this Warranty due to causes beyond its control.

This Warranty becomes effective only upon receipt by Revcon Incorporated of the manufacturer's warranty card, properly filled out by the owner and mailed within thirty (30) days from the date of purchase.
